**SUBJECT:** **Administrative Amendments to the E-mini S&P 500 ESG Index Futures and the E-mini S&P Europe 350 ESG Futures Contracts**

Effective Monday, February 10, 2025, Chicago Mercantile Exchange Inc. ("CME" or "Exchange") will amend Rule 36X01. ("Contract Specifications") of the E-mini S&P 500 ESG Index Futures and the E-mini S&P Europe 350 ESG Futures contracts (the "Contracts").

Effective February 10, 2025, S&P Global ("S&P") advised that they will change the underlying ESG index names in connection with the Contracts in response to the ESMA Guidelines on Funds' Names Using ESG- or Sustainability-Related Terms (see also Exhibit A below).

Specifically, the Exchange will amend Rule 36X01. of the Contracts to reflect the index name change (collectively, the "Rule Amendments").

Each futures contract shall be valued at EUR 500.00 times the ~~S&P Europe 350 ESG Index~~ S&P Europe 350 Scored & Screened Index ("Index").

The Rule Amendments are administrative in nature. There is no economic impact to the Contracts.

The Commodity Futures Trading Commission ("CFTC") will be notified of the Rule Amendments during the week of February 17, 2025, via the weekly notification procedures set forth in Part 40 of the CFTC's Regulations.
