## Option settlement/exercise plans for a National DOM.

- U.S. Equity Index products will close on Globex at 8:30am CT and their settlements will be copy/pasted from the prior business day.
- All other CME/CBOT/NYMEX/COMEX Futures & Options WILL derive settlements on the National DOM trade date.
- U.S. Equity Options scheduled to expire on the National DOM will expire on the day prior using their same methodology currently in place.

## With regard to U.S. Equity Options our rule book states the following:

8. Unscheduled Market Holiday Notwithstanding the aforementioned, if the Primary Listing Exchange (Rule 358A00.A.) is closed in observance of an unscheduled market holiday on a day previously scheduled as a Business Day, then trading in option contracts that had been scheduled to expire on such day shall terminate, and such option contracts shall expire, on the Business Day immediately preceding such unscheduled market holiday.
