2. Definitions

CVOL Information: The Benchmark Information that consists of a cross-asset class family of implied volatility indexes, measuring the market expectation of forward risk, as set out in the methodology, and in the Information Policies, and more specifically section 1 of this Appendix.

Daily Tick File: a static collection of daily Intraday Values.

Delayed End of Day Index: The End of Day Index that is made available more than twenty-four (24) hours after it is calculated.

Delayed Intraday Values: The Intraday Values that are made available more than ten (10) minutes, but less than eight (8) hours after initial calculation.

End of Day Index: The official index value calculated using settlement prices, as per the applicable methodology.

Historical Intraday Values: The Intraday Values that are not Real Time Intraday Values or Delayed Intraday Values, that are made available at least eight (8) hours after initial calculation of the applicable Information.

Intraday Values: The index values that are calculated during the product calculation window as defined in the calculation guide, using real time trading data.

Real-Time Intraday Values: The Intraday Values that are made available within ten (10) minutes of initial calculation.

3. CVOL Information License, Restrictions and Fees

3.1 CVOL Information Internal Display Use.
